SUBSTANCE OF PROPOSED ACTION: To establish additional specific grant requirements for the Alabama Reservoir Management Grants Program.



**220-1-5-.06 Specific Grant Requirements.**

(1) Upon receipt and approval of the grant application, the Department will determine the amount of the grant award and prepare the grant agreement. Payment of grant awards will be contingent upon receipt and approval of the grant agreement.

(2) All Local Public-Private Partnerships that choose to apply jointly shall enter into a binding agreement that designates a lead applicant and describes how the funds will be disbursed and used. The applicant shall submit all required documents on behalf of the local entities which are party to the agreement. Such applications and submittals shall be equivalent to those required if each local government were applying individually.

(3) Applicants shall provide the Department with information on any previous state or federal grants received for the purpose of work related to the grant application received by the jurisdiction during the previous 36 months. This information shall include the grant amount, the grant period, and other information or data as set forth in the application forms.

This rule has no economic impact.

This rule has an economic impact, as explained below:

1. NEED/EXPECTED BENEFIT OF RULE:

This rule establishes the procedures for the disbursement of reservoir management and reservoir debris management grants to qualified local entities for use in controlling invasive aquatic species in State Reservoirs; removing debris from navigable waters; and installing, maintaining, and repairing navigational aids or regulatory signs that are officially designated by Alabama State Law Enforcement Agency.

2. COSTS/BENEFITS OF RULE AND WHY RULE IS THE MOST EFFECTIVE, EFFICIENT, AND FEASIBLE MEANS FOR ALLOCATING RESOURCES AND ACHIEVING THE STATED PURPOSE:

There are no additional costs associated with this rule. The Alabama Reservoir Management Grants Program is intended to aid qualified local entities in controlling invasive aquatic species in State Reservoirs; removing debris from navigable waters; and installing, maintaining, and repairing navigational aids or regulatory signs that are officially designated by Alabama State Law Enforcement Agency. Qualified local entities are required to contribute funds equal to 50 percent of

the total amount of the grant award.

3. EFFECT OF THIS RULE ON COMPETITION:

There will likely be no effect on competition.

4. EFFECT OF THIS RULE ON COST-OF-LIVING AND DOING BUSINESS IN THE GEOGRAPHICAL AREA WHERE THE RULE IS TO BE IMPLEMENTED:

This rule should have a minimal impact, if any, on the cost of doing business. There should be no impact on the cost-of-living.

5. EFFECT OF THIS RULE ON EMPLOYMENT IN THE GEOGRAPHICAL AREA WHERE THE RULE IS TO BE IMPLEMENTED:

There should be no negative impact on employment in the geographical area. Qualified local entities awarded grant money may employ additional people or entities to carry out the grant projects.

6. SOURCE OF REVENUE TO BE USED FOR IMPLEMENTING AND ENFORCING THIS RULE:

Revenue for implementing this rule comes from the State Reservoir Management Grant Fund in the State Treasury. The fund is subject to appropriations by the Legislature and gifts, grants, and other donations received by the Department for the State Reservoir Management Grant Program or Fund.

7. THE SHORT-TERM/LONG-TERM ECONOMIC IMPACT OF THIS RULE ON AFFECTED PERSONS, INCLUDING ANALYSIS OF PERSONS WHO WILL BEAR THE COSTS AND THOSE WHO WILL BENEFIT FROM THE RULE:

Both the short-term and long-term economic impact is that qualified local entities may receive aid in controlling invasive aquatic species in State Reservoirs; removing debris from navigable waters; and installing, maintaining, and repairing navigational aids or regulatory signs that are officially designated by Alabama State Law Enforcement Agency. The State of Alabama and the public will benefit from this rule.

8. UNCERTAINTIES ASSOCIATED WITH THE ESTIMATED BENEFITS AND BURDENS OF THE RULE, INCLUDING QUALITATIVE/QUANTITATIVE BENEFITS AND BURDEN COMPARISON:

This rule requires those wishing to be awarded

grant money to submit applications for grants from the Program. To be considered, they must be a qualified local entity able to contribute matching funds equal to 50 percent of the total amount of the grant award and meet the other grant requirements and award criteria. There must also be funds available in the State Reservoir Management Grant Fund in the State Treasury.

9. THE EFFECT OF THIS RULE ON THE ENVIRONMENT AND PUBLIC HEALTH:

This rule will improve the environment and public health by aiding in controlling invasive aquatic species in State Reservoirs; removing debris from navigable waters; and installing, maintaining, and repairing navigational aids or regulatory signs that are officially designated by Alabama State Law Enforcement Agency.

10. DETRIMENTAL EFFECT ON THE ENVIRONMENT AND PUBLIC HEALTH IF THE RULE IS NOT IMPLEMENTED:

Without this rule, qualified local entities may face difficulties gathering enough funds for controlling invasive aquatic species in State Reservoirs; removing debris from navigable waters; and installing, maintaining, and repairing navigational aids or regulatory signs that are officially designated by Alabama State Law Enforcement Agency.
