9-11-198	Violation of wire basket laws	\$25	\$100-250
9-11-232	Possession, sale, purchase, etc. of protected non-game birds	\$10-25	\$100-500
9-11-235*	Taking, hunting protected birds and animals at night	\$1000-2000	\$2000-3000, up to 6 months jail, and 3 year revocation of all hunting privileges
9-11-236	Hunting in closed season	\$50-500	\$250-1000 and up to 6 months jail
9-11-241/242	Hunting without permission	\$250-500	\$1000 and at discretion of court 1 year revocation of all hunting privileges (2 nd offense \$2000, 10 to 30 days in jail and 1 year revocation of all hunting privileges)
9-11-255	Transportation, shipment of protected game without license	\$25-50	\$250-500
9-11-257	Hunting from a public road	\$250-500	\$1000 (2 nd offense \$2000 and 1 year revocation of all hunting privileges)
9-11-261	Propagating game birds, game etc. without permit	\$25-100	\$250-500

Note: **9-11-235** would be classified as a Class B misdemeanor; all other violations are Class C misdemeanors.
