Instructions for 2018 Alabama Commercial Paddlefish Permit Entry Form

General Instructions:

Entry forms received by ADWFF that are illegible or incomplete will be returned to the applicant.
Entry forms must be received by ADWFF no later than November 15, 2017 to be eligible for the drawing.

Box 1

To be completed with the applicant's *First Name*, *Last Name* (required) and *Middle Initial* as appropriate.

Box 2

To be completed with the applicant's **legal physical address** (required); if the applicant routinely receives mail at an alternate address (example: Post Office Box), this information should be fully provided in Box 2a.

Box 2a

To be completed only if the applicant routinely receives mail at an address other than their legal physical address.

Box 3

To be completed with the applicant's primary telephone number (required) along with an alternate telephone number, E-mail address and Fax Number if these are available. (This will allow ADWFF to quickly and reliably contact the applicant if necessary.)

Box 4

To be completed with the applicant's currently valid driver's license number; State of issue; date of issue.

Box 5 (Required for Alabama Residents Only)

To be completed with applicants Alabama Freshwater Commercial Fishing License Number for **2016-2017 License Year**.
License years begin on October 1 and end on September 30.

Box 6 (Required for Non-Residents of Alabama Only)

Only residents of the states of Tennessee, Kentucky, Illinois and Missouri are eligible to apply for nonresident paddlefish harvester permits in Alabama since only these states allow Alabama residents to commercially fish for paddlefish in their waters. Applicants that are not Alabama residents must submit photocopies of commercial fish roe harvest permits or licenses that were issued by their State of residence that was valid for the most recent respective license year prior to October 1, 2016 that demonstrates commercial roe fish harvest activity. **Attach photocopies to the entry form for submission.**

Box 7 (Required of all applicants)

Using the numbers 1, 2, and 3; the applicant must indicate his or her priority of choice for obtaining a permit to fish in the three respective Alabama River PMA's. The applicant's first choice should be indicated by entering the number "1" within the appropriate box; second choice with the number "2" and the third choice with the number "3". **If the applicant is only interested in fishing in one or two selected PMA's the applicant should indicate those choices as desired and use the number "0" to indicate any PMA's that the applicant has no desire to fish.**
