

## 65+ OPTIONAL HUNTING / FISHING

### NOTE:

- The 65+ OPTIONAL licenses provide a way for those exempt that wish to continue purchasing annual licenses to support wildlife and fisheries programs.
- Each license dollar is matched with federal dollars on a 3:1 basis.
- Residents 65 and over are EXEMPT from purchasing recreational:
  - Hunting
  - Freshwater fishing
  - Saltwater fishing
  - WMA licenses
  - State duck stamp
- Residents 65 and over are NOT EXEMPT from:
  - Baiting Privilege
  - Nighttime Feral Swine and/or Coyote Hunting
  - Federal Duck Stamp
  - Saltwater Angler Registry
  - SW Reef Fish
  - Spearfishing

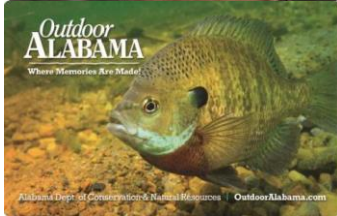
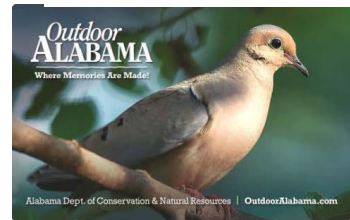
Deer Design



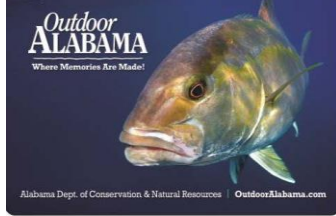
Turkey Design



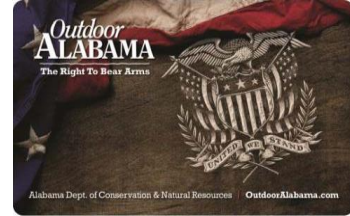
Waterfowl Design
