## **NOTE:**

- **Alabama Residents 65 and over are EXEMPT from purchasing the licenses below.**
- License valid for lifetime (even if moves out of state).
- This license provides a way for those exempt that wish to continue purchasing annual licenses to support wildlife and fisheries programs.
- You will receive an embossed lifetime license card signifying your contribution to hunting, fishing and conservation.
- Your money goes to the game and fish lifetime trust fund and only the interest will be utilized each year for operation of the program.
