

## **DCNR REGISTRATION PRIVILEGE**

*(Does not include any hunting privileges)*

**Valid: Sept 1 – Aug 31**

*Resident & Non-Resident*

### **PRIVILEGE:**

- *Resident and non-resident hunters who are interested in registering for a Special Opportunity Area (SOA) limited quota permit and do not have a current Alabama hunting license, can obtain a “DCNR Registration Privilege” at no cost to get a Conservation ID (CID) number for registration.*

### **NOTE:**

- ***If selected for an SOA permit, a valid Alabama hunting and WMA license must be purchased PRIOR to hunting.***
- *Not needed if purchasing any other annual recreational privilege.*
- *This does not include any hunting privileges.*

### **COST:**

- *No Charge*
