**NOTE:**

- The 65+ OPTIONAL licenses provide a way for those exempt that wish to continue purchasing annual licenses to support wildlife and fisheries programs.
- Each license dollar is matched with federal dollars on a 3:1 basis.
- Residents 65 and over are **EXEMPT** from purchasing recreational hunting, freshwater fishing, saltwater fishing, WMA licenses and state duck stamp.
- Residents 65 and over are **NOT EXEMPT** from:
  - Baiting Privilege
  - Nighttime Feral Swine and/or Coyote Hunting
  - Federal Duck Stamp
  - Saltwater Angler Registry
  - SW Reef Fish
  - Spearfishing
