

COLLEGE STUDENT HUNTING / FISHING LICENSE

Valid: Sept 1 – Aug 31

Non-Resident

Alabama Game, Fish and Wildlife Law; Article 2; beginning with 9-11-73

PRIVILEGE:

- To allow certain non-resident students to qualify for annual resident recreational hunting and fishing licenses.

REQUIREMENTS:

- Must be age 17-23
- Must be a full-time student
- Must be enrolled in an approved AL Higher Education Institute
- Must reside in Alabama

NOTE:

- Non-residents (including college students) cannot purchase lifetime privileges.
- List of approved institutions can be found on the AL Higher Education Institute website.

HUNTER EDUCATION:

- Hunter Education certification required if born on or after August 1, 1977.
- Utilizing Hunting Privileges included with the Wildlife Heritage License will require a Hunter Education # or status of SUPERVISION.



- Your name, information, and annual hunting and fishing privileges will be displayed on the back.






Turkey Design




Watchable Wildlife Design
