- (g) _____ Applicant must ensure that any projects undertaken through grant funds received under this program do not conflict or interfere with any right or obligation of an owner or operator of such State Reservoir or otherwise create any duty or liability for such owner or operator.
- (h) _____ Applications which have not met their obligations under the terms of any previous grant agreements or accounted for any unused grant funds from a previous grant awarded under this rule during the previous 36 months shall be denied by the Department.
- (i) _____ Applicant must document availability of contribution of matching funds equal to 50 percent of the total amount of the grant award.
- (j) _____ Applicant must obtain written concurrence for the project from the owner or operator, or both, of the applicable State Reservoir.

4. SUPPORTING DOCUMENTATION. Submissions must include all the information outlined herein, including: a (1) Completed Application form; (2) Written Concurrence for Project from the Owner and Operator of the State Reservoir; (3) Proof of availability of matching funds; (4) Binding Agreement for Public-Private Partnerships; and (4) Documentation on any previous state or federal grants received for related work in the past 36 months; and a recent W-9.
