



Cedar Creek, Portland Landing and Uchee Creek Special Opportunity Area Hunt Guidelines/Rules

Successful applicants may be accompanied by hunting guest(s) as outlined below. Permit holders and their appropriate guest(s) must remain within their assigned hunt unit during hunting. Each hunting unit is clearly defined on the Special Opportunity Area (SOA) map and delineated with signage on the ground.

Following hunt registration and permit selection, permit holders will receive an email within a couple weeks covering specific SOA information, scouting information and unit assignments.

Note:

- A State Hunting License and Wildlife Management Area (WMA) License are required by all limited quota permit holders and guests unless exempt from needing such license. The WMA License is not needed for the Squirrel Hunt.
- Statewide antlered buck season bag limit applies to all SOAs and all deer harvested are to be recorded at the check station or kiosk and reported through Gamecheck.
- Administrators of the hunt shall have the right to inspect all vehicles or other equipment while on the areas.
- Any violation of SOA rules and regulations (220-2-.55) or any other regulation or law while hunting on Cedar Creek, Portland Landing and Uchee Creek SOA will result in that individual losing their eligibility for future SOA hunts.
- Failure to unregister for an upcoming hunt outside of 7 days prior to your permitted hunt start date and failure to notify WFF personnel of cancellation within 7 days of the hunter's assigned hunt dates at Cedar Creek, Portland Landing and Uchee Creek SOA will result in that individual losing their eligibility for future SOA hunts.
- Hunters shall only hunt and/or scout in their assigned unit(s).

(8) Hunting on Cedar Creek, Crow Creek, Fred T. Stimpson, Portland Landing, Uchee Creek and Upper State Special Opportunity Areas (SOA) will be permitted through a limited quota permit system selected by random computerized selection. Participants are required to attain a Conservation Identification Number (CID) and apply through www.outdooralabama.com to register for a limited number of quota permits available for hunts on these AREAS. All successful applicants must attain and have in possession a valid alabama hunting license, WMA license and

state and federal duck stamps if applicable. **Any violation of any rules, regulations or law, by permit holder or guest, while hunting on any SOA will result in that individual forfeiting the remainder of their hunt and losing their eligibility for future SOA hunts.** Failure to participate in solicited hunt without providing Wildlife and Freshwater Fisheries 7 days prior notice of cancellation will result in that individual losing their eligibility for future SOA hunts. Hunters and guests shall only hunt and scout in their assigned hunt unit(s). All deer and turkey hunters are required to report all deer harvests per Gamecheck System requirements per regulation 220-2-.146. Other requirements for hunters participating in limited quota hunts on the SOAs include:

A. On Cedar Creek, Portland Landing and Uchee Creek SOA:

1. It shall be unlawful to hunt on any SOA unless selected by random draw for a limited quota permit for specific hunt dates on the assigned SOA and hunt unit(s). The permit holder and one guest may only access (excluding approved scouting days) and hunt the assigned SOA and hunt unit(s) for those permitted days. No substitutions will be allowed.
2. Each deer hunt begins at noon on Day 1 and ends on Day 4 of the hunt at noon. On other days of the hunt, hunters may enter the SOA 1 ½ hour prior to legal sunrise and must exit the AREA by 1 ½ hour after legal sunset.
3. During deer and turkey hunts, travel to and from assigned hunt units shall be from 1 ½ hour prior to legal sunrise and up to 1 ½ hour after legal sunset and between 10:00 AM and 2:00 PM.
4. Antlered bucks harvested are required to have a minimum main beam spread of 16” (outside the ears) or 18” main beam (3x the length of the ear). One antlered buck and three antlerless deer per hunter per permit duration.
5. **Deer hunters are required** to record data of harvest date, sex, lactation presence, weight, extract jawbone, hunter observation data sheet and antler measurements on provided data forms at SOA kiosk.
6. **Turkey hunters are required** to record data of harvest date, weight, spur length, beard length and hunter observation data sheet on provided data forms at SOA kiosk.
7. **Hunters are required** to email pictures of their harvest to the managing biologist.

(10) A Wildlife Management Area License (required for deer, turkey and waterfowl), PLUS the applicable Resident or Non-Resident Hunting License [for Alabama residents 16 through 64 years of age and for non-residents 16 years of age and older], PLUS a Wildlife Management Area Permit [free of charge], are required for hunting on AREAS; provided however, that properly licensed persons under the “Wildlife Heritage License” may hunt legal small game except waterfowl on AREAS without the other licenses described herein. PLUS, in order to hunt waterfowl on AREAS,

all persons must have, in addition to the otherwise required licenses and permit, a HIP and valid State (ages 16 through 64) and a valid Federal (ages 16 and over) Waterfowl Stamp.

One antlered buck and 3 antlerless deer per hunter per 4-day hunt. ***Antlered buck restrictions apply.** By limited quota permit only for the properly licensed hunter. The permit holder may have one properly licensed hunting guest on that specified hunt date and in specified hunt unit. Permit and specified hunt unit to be determined through random draw.
 - (Gun) Stalk Hunting Antlerless Deer Only: Nov. 7-10. Four antlerless deer per hunter per 4-day hunt. By limited quota permit only for the properly licensed hunter. The permit holder may have one properly licensed hunting guest on that specified hunt date and in specified hunt unit. Permit and specified hunt unit to be determined through random draw.
 - (Primitive Weapons) Stalk Hunting Hunter's Choice: Nov. 18-21. One antlered buck and 3 antlerless deer per hunter per 4-day hunt. ***Antlered buck restrictions apply.** By limited quota permit only for the properly licensed hunter. The permit holder may have one properly licensed hunting guest on that specified hunt date and in specified hunt unit. Permit and specified hunt unit to be determined through random draw.
 - (Gun) Stalk Hunting Hunter's Choice: Dec. 5-8, Dec. 26-29, Jan. 2-5, Jan. 23-26, Feb. 6-9. One antlered buck and 3 antlerless deer per hunter per 4-day hunt. ***Antlered buck restrictions apply.** By limited quota permit only for the properly licensed hunter. The permit holder may have one properly licensed hunting guest on that specified hunt date and in specified hunt unit. Permit and specified hunt unit to be determined through random draw.

***To be legal for harvest, antlered bucks must have:**

- **Main beam spread width of 16” (outside the ears) or 18” main beam (3x length of the ear).**
- **Hunters are required to record data of harvest date, sex, lactation presence, weight, extract jawbone and antler measurements at kiosk.**
- **Hunters are required to email pictures of their harvest to the district biologist.**

TURKEY:

Mar. 28-30, Apr. 3-5, Apr. 17-19, Apr. 24-26, May 1-3. One gobbler per hunter per 3-day hunt. By limited quota permit only for the properly licensed hunter. The permit holder may have one properly licensed hunting guest on that specified hunt date and in specified hunt unit. Permit and specified hunt unit to be determined through random draw.

RABBIT & SQUIRREL:

Feb. 15-16, Feb. 22-23 and Feb. 29-Mar. 1. By limited quota permit only for the properly licensed hunter. The permit holder may have three properly licensed hunting guests on that specified hunt date and in specified hunt unit. Permit and specified hunt unit to be determined through random draw.

BOBCAT, COYOTE, FERAL SWINE

& FOX:

Open during any scheduled Special Opportunity Hunting Season using weapons and ammunition approved for those hunts. No Dogs Allowed. Daylight Hours Only. Limited to those limited quota permit holders for the specified permit days and units.

c) PORTLAND LANDING SPECIAL OPPORTUNITY HUNTING AREA

(Dallas County)

DEER:

(Archery)

Stalk Hunting Hunter’s Choice: Oct. 17-20, Oct. 24-27, Oct. 31-Nov. 3. One antlered buck and 3 antlerless deer per hunter per 4-day hunt. ***Antlered buck restrictions apply.** By limited quota permit only for the properly licensed hunter. The permit holder may have one properly licensed hunting guest on that specified hunt date and in specified hunt unit. Permit and specified hunt unit to be determined through random draw.

(Gun) Stalk Hunting Antlerless Deer Only: Nov. 7-10. Four antlerless deer per hunter per 4-day hunt. By limited quota permit only for the properly licensed hunter. The permit holder may have one properly licensed hunting guest on that specified hunt date and in specified hunt unit. Permit and specified hunt unit to be determined through random draw.

(Primitive Weapons) Stalk Hunting Hunter's Choice: Nov. 18-21. One antlered buck and 3 antlerless deer per hunter per 4-day hunt. ***Antlered buck restrictions apply.** By limited quota permit only for the properly licensed hunter. The permit holder may have one properly licensed hunting guest on that specified hunt date and in specified hunt unit. Permit and specified hunt unit to be determined through random draw.

(Gun) Stalk Hunting Hunter's Choice: Dec. 5-8, Dec. 26-29, Jan. 2-5, Jan. 23-26, Feb. 6-9. One antlered buck and 3 antlerless deer per hunter per 4-day hunt. ***Antlered buck restrictions apply.** By limited quota permit only for the properly licensed hunter. TURKEY: Mar. 28-30, Apr. 3-5, Apr. 17-19, Apr. 24-26, May 1-3. One gobbler per hunter per 3-day hunt. By limited quota permit only for the properly licensed hunter. The permit holder may have one properly licensed hunting guest on that

specified hunt date and in specified hunt unit. Permit and specified hunt unit to be determined through random draw.

RABBIT & SQUIRREL:

Feb. 15-16, Feb. 22-23 and Feb. 29-Mar. 1. By limited quota permit only for the properly licensed hunter. The permit holder may have three properly licensed hunting guest on that specified hunt date and in specified hunt unit. Permit and specified hunt unit to be determined through random draw.

BOBCAT, COYOTE, FERAL SWINE

& FOX:

Open during any scheduled Special Opportunity Hunting Season using weapons and ammunition approved for those hunts. No Dogs Allowed. Daylight Hours Only. Limited to those limited quota permit holders for the specified permit days and units.
