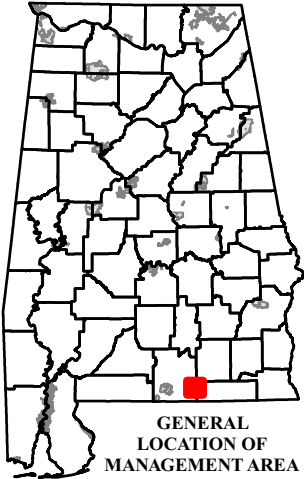

This AREA Permit must be signed and in your possession along with the appropriate license(s) in order to be valid.

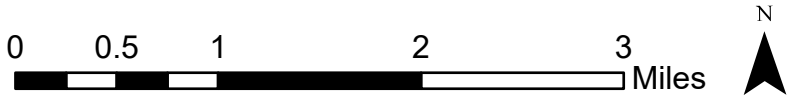

Hunting Regulations – September 2021– August 2022

LICENSE/PERMIT REQUIREMENTS:

- In compliance with 220-2-.55, a Wildlife Management Area License (required for deer, turkey and waterfowl), the applicable Resident or Non-Resident Hunting License [for Alabama residents 16 through 64 years of age and for non-residents 16 years of age and older], are required for hunting on AREAS; provided however that properly licensed persons under the “Wildlife Heritage License” may hunt legal small game, except waterfowl, on AREAS without the other licenses described herein. In order to hunt waterfowl on AREAS, all persons must have, in addition to the otherwise required licenses and permit, a HIP and valid State (ages 16 through 64) and Federal (ages 16 and over) Waterfowl Stamp.
- In addition to license and stamp requirements, an AREA Permit and a WMA daily permit are required unless using the Outdoor Alabama WMA Check-In application to check in and out each hunt day.

NOTES:

- Statewide antlered buck season bag limit applies to all WMAs.
- Youth hunters on youth deer and turkey hunts must be less than 16 years of age. Supervisors must be 21 years old or older, or a parent, and must be properly licensed. Youth must remain within 30 feet of supervisors at all times.
- Administrators of the hunt shall have the right to distribute the hunters and to inspect all vehicles or other equipment while on the WMA. The Department of Conservation and Natural Resources and landowners, who are making the hunting possible, hereby put each hunter on notice that he hunts at his own risk and the Department of Conservation and Natural Resources and such landowners shall not be responsible for any accidents or injuries that may occur.

DATA COLLECTION:

All deer harvested must be submitted at check station for collection of biological data on mandatory days specified below. The results of all hunts must be recorded using the Outdoor Alabama App or Daily Permit and submitted at kiosk at the conclusion of every hunt day.

HUNTING DATES:

DEER:	(Archery)	Stalk Hunting Antlered Bucks Only: <b>Oct. 15-24.</b> One antlered buck per day. <b>*Antlered buck restrictions apply.</b> Stalk Hunting Hunter’s Choice: <b>Oct. 25 – Feb. 10.</b> Two deer per day, one unantlered deer and one antlered buck. No stalk hunting on days of dog deer or youth gun hunts. Archery hunters must harvest antlered bucks on days of antlered buck only gun deer hunts. <b>Archery hunters must abide by all gun deer hunt regulations when hunting on days of gun deer hunts and MANDATORY check station day requirements.</b> <b>*Antlered buck restrictions apply.</b>
	(Youth)	Dog Hunting Hunter’s Choice: <b>Nov. 13.</b> Two deer per day, one unantlered deer and one antlered buck. By Limited quota permit only. Dogs must be approved by DCNR personnel. <b>* No antler restrictions apply. It is MANDATORY to bring all deer harvested on Nov. 13 to the check station for analysis and data collection. Check station will be open from 8:00 AM to 7:00 PM.</b>
	(Primitive Weapons)	Stalk Hunting Hunter’s Choice: <b>Nov. 15-19.</b> Two deer per day, one unantlered deer and one antlered buck. <b>*Antlered buck restrictions apply.</b>
	(Gun)	Stalk Hunting Hunter’s Choice: <b>Nov. 24-28, Dec. 15-19 and Dec. 29 - Jan. 2.</b> Two deer per day, one unantlered deer and one antlered buck. <b>*Antlered buck restrictions apply. It is MANDATORY to bring all deer harvested on Nov. 25-27, Dec. 16-18 and Dec. 30-31 (including archery) to the check station for analysis and data collection. Check station will be open from 8:00 AM to 7:00 PM.</b> Stalk Hunting Antlered Bucks Only: <b>Jan. 12–16, and Feb. 1-10 (Feb. 5 Bonus Buck Day, must be validated by WFF personnel).</b> One antlered buck per day. <b>*Antlered buck restrictions apply. It is MANDATORY to bring all deer harvested on Jan. 13-15 and Feb. 3-5 (including archery) to the check station for analysis and data collection. Check station will be open from 8:00 AM to 7:00 PM.</b>
	(Dog)	Dog Hunting Antlered Bucks Only: <b>Dec. 10-11.</b> One antlered buck per day. By Limited quota permit only. Dogs must be approved by DCNR personnel. <b>*Antlered buck restrictions apply. It is MANDATORY to bring all deer harvested on Dec. 10-11 to the check station for analysis and data collection. Check station will be open from 8:00 AM to 7:00 PM.</b>
<b>*To be legal for harvest, antlered bucks must have at least three (3) antler points (1 inch or longer) on at least one main beam.</b>		

TURKEY:	(Youth)	<b>Mar. 26 (Daylight until 1:00 PM).</b> Gobblers only.
	(Physically Disabled)	<b>Mar. 31 (Daylight until 1:00 PM).</b> Gobblers only.
	(Regular)	<b>Apr. 1 – May 8 (Daylight until 1:00 PM).</b> Gobblers only.

**Bag Limit - No more than 1 gobbler during the first 10 days of each season.**  
**No decoys allowed for the first 10 days.**  
**No more than 2 gobblers total per season from Geneva State Forest WMA.**

CROW:	<b>Sep. 11 – Mar. 6.</b> No hunting on days of youth, dog, gun and primitive weapons deer hunts.
DOVE:	<b>State seasons</b> (12:00 noon to sunset). Saturdays and Wednesdays only. No hunting on days of youth, gun, dog, and primitive weapons deer hunts.
RABBIT & SQUIRREL:	<b>Sep. 11 - Mar. 6.</b> No hunting on days of youth, gun, dog, and primitive weapons deer hunts. Fox squirrel season closed during February and March.
RACCOON, OPOSSUM, & FOX:	<b>Sep. 11 – Mar. 6.</b> (nighttime hours only). No hunting on nights preceding or nights of youth, dog, gun, and primitive weapons deer hunts. Fox hunting - dogs only, no weapons. <b>Nov. 6 - Feb. 28.</b> No hunting on days of youth, gun, dog, and primitive weapons deer hunts.
QUAIL:	<b>State seasons.</b> No hunting on days of youth, gun, dog, and primitive weapons deer hunts.
WATERFOWL:	<b>State season.</b> No hunting on days of youth, primitive weapon and gun deer hunts.
WOODCOCK & SNIPE:	
COYOTE, BOBCAT, RACCOON, OPPSSUM & FOX:	Open during any other scheduled WMA Hunting Season using weapons and ammunition approved for those hunts. No dogs allowed. Daylight hours only.
FURBEARER TRAPPING (excluding feral swine):	<b>Oct. 30 – Feb. 28.</b> (Excluding Dec. 10-11). Trapping permits must be obtained from Area Biologist.

**BAG LIMITS:**  
*Deer* – see above deer hunt schedule for limits; ***Turkey (Gobblers only)* – no more than 1 gobbler during the first 10 days of each season (2 per season);** *Crow* - No Limit; *Dove* – 15 a day; *Rabbit* - 8 per day; *Squirrel* - 8 per day; *Raccoon* - 5 per day; *Opossum* - No Limit; *Fox* - 1 per day; *Quail* - 8 a day; *Waterfowl* – State bag limit; *Woodcock* - 3 per day; *Snipe* – 8 a day; *Feral Swine*, *Bobcat*, and *Coyote* - No Limit; Falconers may take migratory game birds (not more than 3 per day in aggregate combination) and resident game birds and animals following the bag limits listed above for firearms and archery.

PERMITTED FIREARMS, BOW AND ARROW, & FALCONRY:

All WMA Seasons: Weapons and ammunition defined in 220-2-.55 (excluding buckshot) and archery equipment in 220-2-.03.  
Falconry will be legal on all WMA scheduled hunts for legally permitted falconers; following the dates those seasons are open on each WMA.

To hunt, trap, use dogs, possess firearms, traps, or bow and arrow, except on open designated target ranges and except bow fishing equipment, without a valid Area Permit, or by using the Outdoor Alabama App. An AREA permit or Outdoor Alabama App Check-In application is valid only during scheduled AREA seasons during legal hunting hours and only with the required hunting license(s) and stamps and only with weapons and ammunition permitted for hunting the wildlife listed on permit.  | 7. To kill or willfully molest any species of wildlife except those designated game species will legally hunting.  |   |
| 2. For any person to possess or to carry in or on a vehicle, any of the following: any firearm [including pistols/handguns] with ammunition in the magazine, breech or clip attached to firearms, or black powder weapons with primer, cap or flash powder in place, or cocked crossbow. (Nothing in this regulation prohibits or requires an AREA Permit for the possession of handguns by lawfully licensed persons for personal protection, provided the handguns are not used to hunt or take or to attempt to take wildlife except as otherwise provided by this regulation.) | 8. | 3. To use dogs for hunting of deer, turkey, or feral swine. (Leashed dogs may be used for the express purpose of retrieving wounded deer, limited to two dogs per tracking event).   | 9. For any person to hunt or trap any wildlife species (except turkey, migratory birds, and while hunting legally designated species during legal nighttime hours) without wearing a minimum of 144 square inches of hunter orange or full sized hunter orange hat, except when hunting from an elevated tree stand twelve (12) feet or more from the ground, when hunting in an enclosed blind, or when traveling in an enclosed vehicle. | 6. To camp in the WMA except in designated sites. Individuals or groups may camp on the WMA for a period not to exceed nine (9) days in any 30-day period. To erect any permanent tree stand; install any screw-in style steps, spikes, or nails; or otherwise damage any tree.  |
