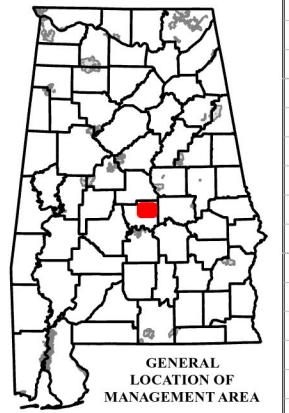

Hunting Regulations – September 2022– August 2023

LICENSE/PERMIT REQUIREMENTS:

- In compliance with 220-2-.55, a Wildlife Management Area License (required for deer, turkey and waterfowl), plus the applicable Resident or Non-Resident Hunting License [for Alabama residents 16 through 64 years of age and for non-residents 16 years of age and older], are required for hunting on AREAS; provided however that properly licensed persons under the “Wildlife Heritage License” may hunt legal small game, except waterfowl, on AREAS without the other licenses described herein. Plus, in order to hunt waterfowl on AREAS, all licensed hunters must have, in addition to the otherwise required licenses, a current HIP certification and valid State (ages 16 through 64) and Federal (ages 16 and over) Waterfowl Stamp.
- In addition to license and stamp requirements, an AREA Permit and a WMA daily permit are required unless using the Outdoor Alabama WMA Check-In application to check in and out each hunt day.

NOTES:

- Statewide antlered buck season bag limit applies to all WMAs.
- Youth hunters on youth deer and turkey hunts must be less than 16 years of age. Supervisors must be 21 years old or older, or a parent, and must be properly licensed. Youth must remain within 30 feet of supervisors at all times.
- Administrators of the hunt shall have the right to distribute the hunters and to inspect all vehicles or other equipment while on the WMA. The Department of Conservation and Natural Resources and landowners, who are making the hunting possible, hereby put each hunter on notice that he hunts at his own risk and the Department of Conservation and Natural Resources and such landowners shall not be responsible for any accidents or injuries that may occur.

DATA COLLECTION:

All deer harvested must be submitted at check station for collection of biological data on mandatory days specified below. The results of all hunts must be recorded using the Outdoor Alabama App or Daily Permit and submitted at kiosk at the conclusion of every hunt day.

HUNTING DATES:

DEER:	(Archery)	<u>Stalk Hunting Hunter’s Choice: Oct. 15 – Feb. 10.</u> One deer a day, either one unantlered deer or one antlered buck. <b>*Antlered buck restrictions apply.</b> Archery hunters must harvest antlered bucks on days of antlered buck only gun deer hunts. No hunting on days of youth gun deer hunt. <b>Archery hunters must abide by all gun deer hunt regulations when hunting on days of gun deer hunts and MANDATORY check station day requirements.</b>
	(Youth)	<u>Stalk Hunting Hunter’s Choice: Nov. 12 – 13.</u> One deer a day, either one unantlered deer or one antlered buck. <b>No antler restrictions apply. MANDATORY to bring all deer harvested on Nov. 12 to the check station for data collection. The check station will be open from 9:00 AM to 7:00 PM.</b>
	(Primitive Weapons)	<u>Stalk Hunting Hunter’s Choice: Nov. 14 – 18 and Dec. 5 – 11.</u> One deer a day, either one unantlered deer or one antlered buck. <b>*Antlered buck restrictions apply. MANDATORY to bring all deer harvested on Dec. 10 (including archery) to the check station for data collection. The check station will be open from 9:00 AM to 7:00 PM.</b>
	(Gun)	<u>Stalk Hunting Hunter’s Choice: Nov. 19 – 20.</u> One deer a day, either one unantlered deer or one antlered buck. <b>*Antlered buck restrictions apply. MANDATORY to bring all deer harvested on Nov. 19 (including archery) to the check station for data collection. The check station will be open from 9:00 AM to 7:00 PM.</b>
	(Gun)	<u>Stalk Hunting Antlered Bucks Only: Nov. 24 – 27, Dec. 22 – 25, Dec. 29 – Jan. 1, Jan. 19 – 22, and Feb. 2 – 5.</u> One antlered buck a day. <b>*Antlered buck restrictions apply. MANDATORY to bring all deer harvested on Nov. 26, Dec. 31, Jan. 20 - 21, and Feb. 3 - 4 (including archery) to the check station for data collection. The check station will be open from 9:00 AM to 7:00 PM.</b>
<b>* To be legal for harvest, antlered bucks must have at least three (3) antler points (1 inch or longer) on at least one main beam.</b>		
TURKEY:	(Youth)	<b>March 25 (Daylight until 1:00 PM).</b> Gobblers only.
	(Physically Disabled)	<b>March 31 (Daylight until 1:00 PM).</b> Gobblers only.
	(Regular)	<b>April 1 – May 8 (Daylight until 1:00 PM).</b> Gobblers only.

Bag Limit – No more than 1 gobbler during the first 10 days of each season.

No decoys allowed for the first 10 days of the WMA regular season.

No more than 2 gobblers total per hunter from Charles D. Kelley-Autauga WMA.

RACCOON & OPOSSUM:	<b>Sept. 1 – March 5.</b> Nighttime hours only. No hunting on days of youth, primitive weapons, or gun deer hunts.
CROW:	<b>Sept. 1 – March 5.</b> No hunting on days of youth, primitive weapons, or gun deer hunts.
DOVE:	<b>State season.</b> (12:00 noon to sunset). Wednesdays and Saturdays only. No hunting on days of youth, primitive weapons, or gun deer hunts.
RABBIT & SQUIRREL:	<b>Sept. 10 - March 5.</b> Fox squirrel season closed during February and March. No hunting on days of youth, primitive weapons, or gun deer hunts.
QUAIL:	<b>Nov. 5 – Feb. 28.</b> No hunting on days of youth, primitive weapons, or gun deer hunts.
SNIPE:	<b>State season.</b> No hunting on days of youth, primitive weapons, or gun deer hunts.
GOOSE:	<b>State season.</b>
WATERFOWL:	<b>State season.</b> ½ hour before sunrise to 12:00 noon. No hunting on days of youth, primitive weapons, or gun deer hunts.
WOODCOCK:	<b>State season.</b> No hunting on days of gun deer hunts.
BOBCAT, COYOTE, RACCOON, OPOSSUM, & FOX:	Open during any other scheduled WMA Hunting Season using weapons and ammunition approved for those hunts. No dogs allowed. Daylight hours only.
FURBEARER TRAPPING (excluding feral swine):	<b>Oct. 29 – Feb. 28.</b> Trapping permits must be obtained from Area Biologist.

BAG LIMITS:

Deer – see above deer hunt schedule for limits; **Turkey (Gobblers only) – no more than 1 gobbler during the first 10 days of each season (2 per season);** *Raccoon* - 5 per day; *Opossum* - No Limit; *Fox* - 1 per day; *Crow* - No Limit; *Dove* – 15 a day; *Rabbit* - 8 per day; *Squirrel* - 8 per day; *Quail* - 8 a day; *Snipe* – 8 a day; *Waterfowl* – State bag limit; *Woodcock* - 3 per day; *Feral Swine, Bobcat, and Coyote* - No Limit; Falconers may take migratory game birds (not more than 3 per day in aggregate combination) and resident game birds and animals following the bag limits listed above for firearms and archery.

PERMITTED FIREARMS, BOW AND ARROW, & FALCONRY:

All WMA Seasons: Weapons and ammunition defined in 220-2-.55 (excluding buckshot) and archery equipment in 220-2-.03.

Falconry will be legal on all WMA scheduled hunts for legally permitted falconers; following the dates those seasons are open on each WMA.
