## NOTICE OF INVITATION FOR BIDS FOR THE SALE OF STATE LAND LOCATED IN MOBILE COUNTY, ALABAMA

Notice is hereby given pursuant to <u>Code of Alabama</u>, 1975, Section 9-15-70 et seq. that **SEALED BIDS** for the sale of state property located in Mobile County, Alabama will be **received until JANUARY 22, 2026**, **4:00 P.M.**, as detailed below, by the office of the State Lands Division, Department of Conservation and Natural Resources.

Also pursuant to the above referenced Code Section, officers and employees of the Department of Conservation and Natural Resources and Department of Mental Health, as well as members of their families, shall be excluded from bidding on any property described herein.

The subject site consists of four parcels on Hazelmier Road, just off E. Coy Smith Highway, in Mount Vernon, Alabama. The subject sites range from 25,700 - 33,977 square feet. The total site size of all four parcels is 2.63 acres. Mobile County identifies the subject site as parcel numbers 0207360000016.002, 0207360000016.00, 0207360000016.004, and 0207360000016.005.

The **MINIMUM BID** for the sale is **\$240,000.00**. Specification of a minimum bid amount to be considered does not suggest acceptance of any bid which may equal or exceed that amount. No bid below the applicable minimum bid will be accepted.

EACH bid submitted must be accompanied by a <u>certified</u> or <u>cashier's</u> check (NO PERSONAL CHECKS ACCEPTED) in the amount of \$24,000 as a bid deposit made payable to the State Lands Division which will be forfeited (pursuant to Section 9-15-76) if the bid is accepted and the bidder does not complete the transaction within thirty (30) days of award. Any bid submitted without such check will not be considered. Unsuccessful bidders' deposits will be returned promptly following the bid opening. The successful bidder's bid deposit will be applied to the purchase price.

Each bid must be submitted in a separate envelope clearly marked on the outside "SEALED BID FOR MT. VERNON HOUSES - DO NOT OPEN" and delivered to: State Lands Division, Room 464, Folsom Administrative Building, 64 North Union Street, Montgomery, Alabama 36130-1901 (36104 IF DELIVERED BY PRIVATE COURIER).

NO BID SHALL BE RECEIVED FOR ANY REASON ANY TIME AFTER 4:00 P.M., JANUARY 22, 2026. IT SHALL BE THE SOLE RESPONSIBILITY OF THE BIDDER TO ENSURE ACTUAL RECEIPT OF THE BID BY THE STATE LANDS DIVISION PRIOR TO THIS DEADLINE. All bids received by this deadline will be publicly opened and read on the following day, January 23, 2026,10:00 A.M. in the office of the State Lands Division.

The successful bidder shall reimburse the Alabama Department of Mental Health for the cost of the appraisal, \$2,500, and for the advertisement fees incurred for this notice.

Any conveyance will be made subject to reservation of all oil, gas, and mineral rights as well as rights associated with pore space and to all other restrictions of record.

The State does not warrant nor guarantee title to the lands herein advertised or otherwise warrant or guarantee the condition of the land or any improvements.
